REGULATION SUPERSEDED: 6- 2023/2024

CATCH AREA: ALL PUYALLUP TRIBAL U & A WITHIN WDFW MARINE FISH AREAS **26D, 28A, 28B.**

SPECIES: PACIFIC COD, WALLEYE POLLACK, PACIFIC TOMCOD, PACIFIC WHITING, FLOUNDER, DABS AND SOLES (EXCLUDING PACIFIC HALIBUT), GREENLINGS (EXCLUDING LINGCOD), RATFISH, SABLEFISH, CABEZON, SPINY DOGFISH, ALL SPECIES OF SHARK, ALL SPECIES OF ROCKFISH, ALL SURF PERCHES.

DATE ADOPTED: JULY 23, 2024

EFFECTIVE DATE/TIME: 12 AM AUGUST 1, 2024

LEGAL GEAR:

BEACH SEINES: NOT TO EXCEED 350' IN LENGTH WITH A 1/2" STRETCH MESH MINIMUM.

SET LINES: MINIMUM HOOK SIZE 7/0. SET LINES MUST BE MARKED ON THE SURFACE BY A 24 INCH OR GREATER DIAMETER BUOY BALL. MAXIMUM OF 1,000 HOOKS PER VESSEL

HOOK AND LINE: TWO RODS ALLOWED, EACH WITH ONE LURE (HERRING TYPE BAITS COUNT AS "LURES" AND MAY HAVE ANY NUMBER OF HOOKS)

FISHING SCHEDULE: **OPEN UNTIL FURTHER NOTICE**

AREA 26D:

BEACH SEINE: OPEN FROM SEPT. 1 TO APRIL 30.

HOOK AND LINE: ALL YEAR ROUND-SEE SUBSISTENCE RULES

SET LINE: OPEN ALL YEAR, EXCEPT QUARTERMASTER HARBOR IS CLOSED TO SET NETS AND THOSE WATERS SOUTH OF LINES PROJECTED FROM DASH POINT TO POINT PINER ON MAURY ISLAND AND FROM POINT DALCO TRUE WEST TO THE KITSAP PENINSULA ARE CLOSED TO SET NETS AND SET LINES ALL YEAR.

AREA 28A:

BEACH SEINE: OPEN FROM JANUARY 1 TO APRIL 30.

HOOK AND LINE: ALL YEAR ROUND-SEE SUBSISTENCE RULES

SET LINE: OPEN ALL YEAR, EXCEPT THOSE WATERS NORTH OF A LINE PROJECTED TRUE EAST OF FOX POINT ON FOX ISLAND, AND EAST OF A LINE PROJECTED DUE NORTH FROM THE NORTHWEST TIP OF FOX ISLAND ARE CLOSED ALL YEAR.

AREA 28B:

BEACH SEINE: OPEN FROM JANUARY 1 TO APRIL 30.

HOOK AND LINE: ALL YEAR ROUND-SUBSISTENCE RULES

SET LINE: OPEN ALL YEAR, EXCEPT THOSE WATERS OF CARR INLET NORTH OF NORTH LATITUDE 47 DEGREES AND 20 MINUTES FROM AUGUST 15 THROUGH NOVEMBER 30.

HOOK AND LINE SUBSISTENCE RULES

LINGCOD ALL AREAS OPEN MAY 1ST TO JUNE 15TH 2 LINGCOD PER FISHER PER DAY, NO LINGCOD LESS THAN 22" OR GREATER THAN 40" MAY BE RETAINED

ROCKFISH ALL AREAS OPEN YEAR AROUND, 2 ROCKFISH PER FISHER PER DAY

PACIFIC COD, TOMCOD, WHITING AND POLLACK: ALL AREAS OPEN YEAR AROUND, NO MORE THAN 2 FISH PER DAY COMBINED SPECIES

FLOUNDERS, DABS AND SOLE: ALL AREAS OPEN YEAR AROUND, 6 FISH OF EACH SPECIES MAY BE RETAINED PER DAY, NO SIZE LIMITS

SURFPERCH: ALL AREAS OPEN YEAR AROUND, 10 SURFPERCH PER DAY PER FISHER

SHINER PERCH: ALL AREAS OPEN YEAR AROUND, NO LIMIT

SPECIAL PROVISIONS:

IT IS LAWFUL TO RETAIN SQUID, OCTOPUS, AND SHELLFISH TAKEN INCIDENTAL TO THIS FISHERY, HOWEVER, THE RETENTION OF CLAMS AND OYSTERS IS UNLAWFUL. NO INCIDENTAL SHELLFISH MAY BE SOLD COMMERCIALY.

ALL ENGLISH SOLE MEASURING LESS THAN 12" TOTAL LENGTH AND ALL STARRY FLOUNDER MEASURING LESS THAN 14" TOTAL LENGTH MUST BE RELEASED UNHARMED ALL LINGCOD, PACIFIC HALIBUT, STURGEON AND ROCKFISH MUST BE RELEASED UNHARMED ALL SALMON(INCLUDING STEELHEAD) TAKEN WHILE FISHING FOR BOTTOMFISH MUST BE RELEASED UNHARMED WHILE PARTICIPATING IN COMMERCIAL HARVEST.

CATCH REPORTING: ALL COMMERCIAL HARVEST OF BOTTOMFISH MUST BE REPORTED ON COMMERCIAL FISH TICKETS. ALL SUBSISTENCE CATCH MUST BE REPORTED TO THE PUYALLUP TRIBE'S FISHERIES OFFICE WITHIN 48 HOURS OF LANDING.

EMERGENCY REGULATIONS: ANY PROVISIONS OF THE ABOVE MAY BE MODIFIED AT ANY TIME BY EMERGENCY REGULATION.
