DOWNSTREAM TO THE GREEN LIGHT AT THE RIVER MOUTH

FISHERY TYPE: COMMERCIAL

SPECIES: CHUM

DATE ADOPTED: NOVEMBER 12, 2024

**EFFECTIVE DATE/TIMES: NOON THURSDAY NOVEMBER 14, 2024**

**LEGAL GEAR: DRIFT NETS NOT TO EXCEED 210' IN LENGTH. SET NETS NOT TO EXCEED 60' IN LENGTH.  
BOTH DRIFT AND SET NETS SHALL HAVE A MINIMUM STRETCH MESH SIZE OF 5 1/2 INCHES.**

**OTHER RESTRICTIONS: THE PUYALLUP RIVER IS CLOSED TO SET NET FISHING DOWNSTREAM FROM THE  
PILINGS OF THE OLD RAILROAD BRIDGE LOCATED IMMEDIATELY UPSTREAM FROM THE 11TH STREET  
BRIDGE AND 400' ABOVE AND BELOW CLARKS CREEK MOUTH. THE PUYALLUP RIVER IS CLOSED TO  
DRIFT NET FISHING BETWEEN THE 11TH STREET BRIDGE AND THE PILINGS OF THE OLD RAILROAD  
BRIDGE IMMEDIATELY UPSTREAM FROM THE 11TH STREET BRIDGE. RELEASE WILD STEELHEAD**

FISHERS ARE REQUIRED TO CHECK THEIR SET NETS ONCE EVERY 24 HOURS AND REPORT ALL CATCH NOT  
SOLD ON COMMERCIAL FISH TICKETS TO THE TRIBAL FISHERIES OFFICE WITHIN 24 HOURS OF LANDING  
OR **RECORD THEM ON THE TAKEHOME SECTION OF YOUR FISH TICKET, JUST LET THE FISH BUYERS
