We are entering our election season for 2019. There will be two (2) positions open on the Tribal Council.



Emerald Queen Casino:

I have been the chair for the casino construction and design team meetings for the last year – every Tuesday we ensure that the casino is progressing.

This is our economic engine and when it opens it will be the finest gaming facility in the State of Washington, without a doubt. Our investment in this facility will help carry the economic prosperity for the next generation of Tribal Members into the future. I am so proud to say that we are going to have player tracking, a beautiful casino and hotel that showcases our culture, art, tradition.

Per Capita:

I made the motion to start the Per Capita Program in a membership meeting in 2002. I am big supporter of our Per Capita Program and I will fight to make sure our Per Capita Program continues.

Addiction Crisis:

We have all know, or have known someone that suffers from addiction. I will not stop until our community gets the proper healing. I want the tribe to have its own recovery house that sets up our members for success and is a right step towards a new chapter in life: Job Training, Housing, Education.

Employment:

I am delighted to say that the Puyallup Tribe is one of the top employers in Pierce County. I will continue to fight for great advancement program to provide the

necessary training and experience, and make sure that the PUYALLUP preference is utilized. I am a huge advocate for changing hiring criteria. Our members don't deserve to be turned away; we need to support and give everyone a chance that wants one. Education is key. Our ancestors weren't given this opportunity, and the ability to give our membership opportunities to grow in life is a dream come true!

Cannabis:

I am a big advocate on cannabis throughout the community and country; including in D.C., lobbying to Congress on the medicinal benefits. We signed the Marijuana Compact with the state to open up our own testing lab, producing top quality research to eventually cultivate into use for alternative, natural healing. Now we officially have 2 stores - one in Fife and one in Tacoma. Not only has it been a new opportunity for our economic development growth, it's been able to provide our community a natural way of healing. We are still advancing. This is just the beginning.

Natural Resources:

My Dear Tribal Members,

Thank you all for the support in the primary election. I wanted to let you all know I am a candidate for the general election which will be held on June 1, 2019, from 10 a.m. to 4 p.m. at the Puyallup Tribe's Administration Department.

I am asking for your support on this next general election. I would love to be your next Tribal Council Woman.

I believe in working hard for the Tribal Members. As you all know, I have been working for our Tribe and members for over 40 years; I am currently the Director of Per Capita/ Representative Payee Department. I am a Strong Woman, dependable, trustworthy, dedicated, reliable, educated, and I follow the Tribe's codes, procedures and policies.

I am running for Tribal Council because I want better transparency, better accountability and membership involvement. I want to empower our youth, education and culture; care for and respect our Elders; economic development; protect our Sacred Land.

Listed below are a few ideas that we need to work on as a Tribe:

Membership meetings: need to be organized by a Membership Committee. Topics chosen by members.

Transparency: Assets and debts, economic development, informing the membership first on buying property and new businesses – make it a tribal vote.

Housing for our Members: Most of our Members do not qualify for HUD.

- Build Tribal Members Homes
- Tiny homes and food bank for the homeless
- Jobs and training: train and hire members
- Large Church: location near Elder's Assisted Living/Cemetery - the church can also be used for our funerals.
- Casino Children's Activity **Center:** contains indoor water park, arcade, etc., which is beneficial to tourism and should be located near our new Casino. There is a great spot is where the Old Tent Casino resides.
- Tribal Grocery Store: tribal tax exempt, location in Fife near 70th street; there are lots of new housing developments nearby and the closest grocery store is in Puyallup or Federal Way.
- Per Capita Increase: Trump's new tax law affects all members at 37 percent.
- Build a separate Chief Leschi Elementary School: our younger kids should not be in the same school as the older kids.
- Native Treatment Center: All NW Indian Tribes build a treatment center together, for all Natives.
- Membership Committee: Schedule membership meetings

Puyallup Tribal Members – we need to stand together on protecting our Children, Elders, Water, Land, Fish, Roots, Berries, Education, Culture and most of all, our Sovereignty Rights.

Dear Puyallup Tribal Members,

I would like to thank the present Tribal Council Members and their families for their service, and I would like to express a deep sense of gratitude to each one of our past Tribal Council Members and their families for their sacrifice of service.

I have five categories that I plan to focus on, specifically, but not limited to the following areas:

1. Housing:

Housing is a basic need for survival that needs to be **safe, suitable** and **affordable** for all our Tribal families. We can do this by working together to establish a realistic plan that encompasses a wide range of housing opportunities such as Emergency, Transitional, **Rental** and **Home Ownership**. We can achieve this by purchasing, developing and significantly repairing existing members' homes from the water to the mountains throughout our traditional and ancestral lands.

2. Addiction/Mental Health: Although **drug addiction/abuse** on and off the Reservation is not a new issue, I would like to call to your attention that the present level has grown to a crisis that is affecting our people in many negative ways - even though our Tribe has dedicated workers and offers many different programs. In a collaborative effort with Tribal Council and Land Use, I would like to locate a piece of Tribal property and develop a treatment center that provides detoxification as well as substance abuse and mental health care.

3. Social Services:

It is my desire to work with the **Council** and **Departments** in order to expand the level of assistance by raising financial support in the areas of: Mortgage, Rental, Down **Payment** and **Crisis/Emergency Programs.** The cost of living has gone up, so we should increase the financial support for these service programs.

4.Children Services:

Wherever possible, Family **Reunification** needs to be our top priority for the health, safety and **vitality** of our children. We need to evaluate what works and what doesn't by developing solution-based programs that encourage a proactive approach and a safe place where families can reconnect with the support that they need. Over the years, we have had more of our children entering protective services than ever before.

5. Employment:

We are one of the top employers in Pierce County with over 3,000 employees; but only 500 are Tribal Members. We have Members that can't get a job nor are they being provided with the opportunity to advance into leadership positions. I will work with the Tribal Council to ensure that our right to Tribal Member employment preference is enforced throughout all Tribal entities.

Thank you for your time and I respectfully ask you for not only your vote but also your support and guidance.
